

## Slouchpod Competition Terms and Conditions

In these terms "the Promoter" means 0800 Reverse

4. If a participant is under 13 they must have a parent or guardian permission to enter.
5. Entrants will need to answer a multiple choice question to enter the competition.
6. The winner must have answered the questions correctly and will be the first eligible entry randomly drawn after the closing date from all correct entries received.
